1. Non-transferability and Revocability of Membership

BJ's Wholesale Club Membership Cards are to be used only by the individuals to whom they are issued. Membership is non-transferable. The Primary Member (or an owner or officer of a Business Member) shall have the sole authority to make changes to the Membership and receive and request appropriate information. BJ's reserves the right to require photo identification on Membership Cards. BJ's cashiers will check Membership Cards at point of sale for identity purposes. Supplementary Members and Household Members may receive information about their own Membership. The Primary Member must be 18 years of age to purchase a Membership. Supplemental Members and Household Members under 18 may be added if they reside at the same address. Sale of certain items, including but not limited to alcohol and tobacco, will be subject to legal age restrictions. Additional Supplemental Memberships associated with the Primary are not impacted by or included in the BJ's Rewards® program.

Existing BJ's Members may upgrade their existing Membership to a **BJ's Rewards Membership** at any time for an adjusted fee, based on the number of months remaining on the existing BJ's Membership.

BJ's Rewards® Members receive a Reward, equal to 2% of eligible BJ's purchases made at any BJ's Club location and, effective September 29, 2006, online at BJ's web site(s), www.bjs.com and shop.bjs.com, redeemable **ONLY** toward the future purchases of qualifying merchandise at BJ's Club locations. Calculation of the Reward will not exceed \$500 for a 12-month period.
